Dear Mr. Lerch,

We are pleased to inform you that the project "**ViSiBLE**", submitted under the 5th call for project proposals of the European Territorial Cooperation Programme "Alpine Space", **was approved** by the programme committee in its meeting in Bled on 2nd July 2013 for co-funding with an **ERDF** amount of € **375.972,--**.

The programme committee approved the project proposal with the following recommendations:

- the project should demonstrate its added value and the complementarity to the CABEE activities and other EU funded projects;
- the project should set up a proper timetable for the implementation of the CESBA tool;
- it should be clearly demonstrated how the projects that are part of the CESBA initiative will be involved; the active involvement of the observer network needs to be ensured;
- the split between WP3 and WP5 with regards to the dissemination strategy should be clarified and the dissemination plan should be explicitly targeted at the policy level.

The JTS team will provide you with an overview of the assessment synthesis of your project, including further evaluation details together with a letter requesting minor technical corrections to the application form by mid-July. Please provide the revised file within the deadline given by the JTS.

The programme herewith kindly asks you to demonstrate (via email to MA and JTS) how the recommendations expressed by the programme committee have been taken into account by the programme partnership until **6th September 2013**.

Furthermore, we would like to announce the upcoming **Lead Partner seminar** that will take place from "lunch to lunch" on **10th and 11th September 2013 in Munich**. You will be provided with the respective draft agenda as well as supporting documents on location and hotels well in advance. Please consider that the attendance at this seminar is obligatory. It is a special opportunity to clarify open questions with the programme bodies and to make yourself familiar with the programme's structures and procedures to ensure a proper project start and a further smooth project implementation.

Finally please find attached the electronic version of the **subsidy contract**. We kindly ask you to print two copies, have it signed and stamped and then return both copies to the managing authority for counter signature (either at the occasion of the above mentioned LP seminar or via postal service) by **September 13th 2013** at the latest. **Please be aware that the subsidy contract will not be countersigned before the recommendations have been implemented.**
